Mr. Maldonado was not told this when he purchased it and thinks it is unfair. When it rains his property gets flooded and he would like to see if the Twp. can help him in this matter. Mayor Shivery said that he should to speak with the Construction Code Official, or the NJ DEP.

Stephanie Byrwa of 445 Democrat Rd. said that she was unaware of the Twp. Shred Event and the Twp. Tree Seedling Event. She said that when she went on the Twp. website to see if the notices were there she noticed that the website is not up-to-date and that it is a very poor website. She said the Police Dept. have a page on Facebook and they have a large number of followers, perhaps the Twp. could consider doing the same. She said that she is in the communications business and will volunteer to help with the Twp. website is needed. Mayor Shivery got her phone number from her and will discuss the matter with her.

Lee Lucas of 361 Democrat Rd. asked what the meaning of Resolution #78 is and the Mayor said the clerk will read it for the audience. Lee said that he likes the Resolution and supports the police. Lee asked if the police have body cameras and Mayor Shivery said that they are considering this purchase. Lee doesn't think the cameras are necessary.
