Statement by Mayor Shivery

Good evening and best wishes to everyone for a healthy and Happy New Year in 2015. He congratulated Councilman DiMenna for being re-elected to President of Council. He thanked the voters for electing him to his fifth term as Mayor. He is humbled by their vote of confidence and promises to work for continued success in Greenwich Twp.

Mayor's Remarks:

There are a number of positive signs for the future of our community. Most significant is the sale of the DuPont-Repauno site. This will add new businesses with new jobs, new construction and new ratables. This past year I directed a new tax abatement ordinance to be adopted to attract new businesses and to give reasons for existing businesses to remain and expand. This action has been successful with Thayer Distribution, Inc. greatly expanding its facility on Swedesboro Ave.

This past year brought challenges to our water treatment system by the threat of contamination of PFC's. With the cooperation of Council we were proactive and took prompt action to have a carbon filter treatment system installed in all our public wells. Installation is expected to be completed by June. This will assure us of having the best water in Gloucester County. We will be among the first to have this enhancement in all our wells.

Cost of government continues to be a challenge. It has always been a priority to keep costs stable or reduce them. Our effective tax rate remains among the lowest in Gloucester County. This has been accomplished while avoiding any loss of service. It is my hope we can continue this path.

I want to thank my team of employees, professionals and volunteers who have been with me over the past 12 years for their outstanding efforts. Our municipal employees are great and know their jobs well. Our volunteers who serve on many committees are the best and we should be proud of their service. The professionals do an outstanding job in serving and promoting Greenwich Twp. It is because of this I intend to keep our team in place and hope for the cooperation of Council in keeping a good team together.

The future looks promising for Greenwich Twp. With our low taxes, future business development, and services second to none, people will consider making Greenwich Twp. their home.

Again, I wish to thank the voters, our employees, volunteers and professionals for all their hard work. I am looking forward to the cooperation of Council this coming year. Working together is the key to our success in Greenwich Twp. With cooperation, there is nothing that can prevent our success for the Twp.
